**SUMMONS IN ADMINISTRATIVE REVIEW**

To Each Defendant:

An Administrative Review Action has been filed against you. Read all documents attached to this Summons, including the Complaint.

**FILING AN APPEARANCE:** To participate in the case, you MUST file an official document with the court **within 35 days** after you have been served (not including the day of service). This process is called an “Appearance” and the official document is called an “Answer/Response”. If you do not file an Appearance and Answer/Response on time, the court may decide the case without hearing from you. This is called a “default”. As a result, you could lose the case.

**E-FILING:** You do not need to come to the courthouse to file your appearance/answer. After you fill out the necessary documents, you need to electronically file (e-file) them with the court. To e-file, you must create an account with an e-filing service provider. For more information, go to [ilcourts.info/efiling](http://ilcourts.info/efiling). If you cannot e-file, you can get an exemption that allows you to file in-person or by mail.

**FILING FEES:** You may be charged filing fees, but if you cannot pay them, you can file an Application for Waiver of Court Fees.

**FORMS:** Statewide standardized forms, including the Appearance, Answer and Fee Waiver forms, are available at [ilcourts.info/forms](http://ilcourts.info/forms). Other court forms, specific to Cook County Circuit Court, are available at <https://services.cookcountyclerkofcourt.org/Forms/>.
