REQUEST FOR RELIEF

I request an **Emergency Firearms Restraining Order**.

TO PETITIONER: This orders the Respondent to refrain from having in their custody or control, purchasing, possessing, or receiving additional firearms, ammunition, and firearm parts that could be assembled to make an operable firearm for the duration of the Order. Respondent must also turn over any Firearm Owner’s Identification Card and concealed carry license in their possession to local law enforcement.

You will go to court today and a 14-day Emergency Order MAY be entered without notice given to the Respondent. The Respondent will be notified before your second court date and have the opportunity to be present. The judge will hold a hearing at that time to decide if a 6-Month Firearms Restraining Order will be entered.

I request a **Plenary Firearms Restraining Order (in effect for six months or up to one (1) year)**.

TO PETITIONER: This orders the Respondent to refrain from having in their custody or control, purchasing, possessing, or receiving additional firearms, ammunition, and firearm parts that could be assembled to make an operable firearm for the duration of the Order. Respondent must also turn over any firearm, ammunition, and firearm parts that could be assembled to make an operable firearm or Firearm Owner’s Identification Card and concealed carry license in their possession to local law enforcement.

You will NOT go to court today and NO Order will be entered today. You will get a court date within 30 days of today. The Respondent will be notified ahead of time and have the opportunity to be present. The judge will hold a hearing at that time to decide if a 6-Month Firearms Restraining Order will be entered.

I request that the court issue a **Search Warrant** directing a law enforcement agency to seize the Respondent's firearms, ammunition, or firearm parts that could be assembled to make an operable firearm.

I request, that the court direct the law enforcement agency to **search the Respondent's residence and other places** where I believe they are likely to possess the firearms, ammunition, or firearm parts that could be assembled to make an operable firearm.

TO PETITIONER: In order for a Search Warrant to be issued, the court must find that there is probable cause to believe that the Respondent possesses firearms, ammunition, and firearm parts that could be assembled to make an operable firearm. **You must provide that evidence.**

ALLEGATIONS

The following facts cause me to believe that the Respondent is a danger to themselves or others.

Respondent has recently threatened violence or committed violence toward themselves, or another person.

Respondent has violated any and all protective orders under the Illinois Domestic Violence Act of 1986.

Respondent has a history of mental illness or has previously been treated for mental illness.
