Wherefore, Petitioner requests the entry of Civil No Contact Order setting forth the following remedies:

Prohibit the Respondent from knowingly coming within, or knowingly remaining within, a specified distance from the Petitioner;

Restrain the Respondent from having any contact, including nonphysical contact and electronic communication as defined in Section 26.5-0.1 of the Criminal Code of 2012, with the Petitioner directly, indirectly, or through third parties, regardless of whether those third parties know of the order;

Prohibit the Respondent from knowingly coming within, or knowingly remaining within, a specified distance from the Petitioner’s residence, school, daycare or other specified location;

Order the Respondent to stay away from any property or animal owned, possessed, leased, kept, or held by the Petitioner and forbid the Respondent from taking, transferring, encumbering, concealing, harming, or otherwise disposing of the property or animal; and

Order any other injunctive relief as necessary or appropriate for the protection of the Petitioner.
