YOU ARE SUMMONED TO APPEAR AT A HEARING ON A PETITION FOR APPOINTMENT OF GUARDIAN FOR A PERSON WITH A DISABILITY TO ADJUDGE YOU A PERSON WITH A DISABILITY AND TO HAVE A GUARDIAN APPOINTED TO MAKE DECISIONS FOR YOU REGARDING YOURSELF OR YOUR PROPERTY OR BOTH; A COPY OF THE PETITION IS ATTACHED. AS THE RESPONDENT IN THE PETITION, YOU HAVE CERTAIN RIGHTS UNDER THE LAW; THOSE RIGHTS ARE EXPLAINED IN THE NOTICE OF RIGHTS OF RESPONDENT WHICH IS PRINTED ON THE BACK OF THIS SUMMONS.

FILING AN APPEARANCE: Your appearance date is **NOT** a court date. It is the deadline for filing your appearance/answer. To file your appearance/answer **YOU DO NOT NEED TO COME TO THE COURTHOUSE, unless you are unable to eFile your appearance/answer.** You can download an Appearance form at <http://www.illinoiscourts.gov/Forms/approved/procedures/appearance.asp>. After completing and saving your Appearance form, you can electronically file (e-File) it with the circuit clerk's office.

E-FILING: E-filing is now mandatory with limited exemptions. To e-File, you must first create an account with an e-Filing service provider. Visit <http://efile.illinoiscourts.gov/service-providers.htm> to learn more and to select a service provider.

If you need additional help or have trouble e-Filing, visit <http://www.illinoiscourts.gov/faq/gethelp.asp> or talk with your local circuit clerk's office. If you cannot e-file, you may be able to get an exemption that allows you to file in-person or by mail. Ask your circuit clerk for more information or visit www.illinoislegalaid.org.

FEE WAIVER: If you are unable to pay your court fees, you can apply for a fee waiver. For information about defending yourself in a court case (including filing an appearance or fee waiver), or to apply for free legal help, go to www.illinoislegalaid.org. You can also ask your local circuit clerk's office for a fee waiver application.

COURT DATE: Your court date will be sent to your e-File email account or the email address you provided to the clerk's office. You can also call or email the clerk's office to request your next court date. You will need to provide your case number OR, if unknown, the name of the Plaintiff or Defendant. For criminal case types, you will also need to provide the Defendant's birthdate.

REMOTE APPEARANCE: You may be able to attend this court date by phone or video conference. This is called a "Remote Appearance". NOTICE OF RIGHTS OF RESPONDENT

You have been named as the Respondent in a guardianship Petition asking that you be declared a disabled person. If the Court grants the Petition, a Guardian will be appointed for you. A copy of the Petition for Guardianship is attached for your convenience.

If a Guardian is appointed for you, the Guardian may be given the right to make all important decisions for you, such as where you may live, what medical treatment you may receive, what places you may visit, and who may visit you. A Guardian may also be given the right to control and manage your money and other property, including your home, if you own one. You may lose the right to make those decisions for yourself.

You have the following legal rights:

1. You have the right to be present at the hearing.
2. You have the right to be represented by an attorney, either one whom you retain or one appointed by the Judge.
3. You have the right to ask for a jury of six persons to hear your case.
4. You have the right to present evidence to the Court and to confront and cross-examine witnesses.
5. You have the right to ask the Judge to appoint an independent expert to examine you and to give you an opinion about your need for a Guardian.
6. You have the right to ask that the hearing be closed to the public.
7. You have the right to tell the Court whom you prefer to have for your Guardian.
8. You have the right to ask a judge to find that although you lack some capacity to make your own decisions, you can make other decisions, and therefore it is best for the court to appoint only a limited guardian for you.

You do not have to attend the hearing if you do not want to be there. If you do not attend, the Judge may appoint a Guardian if the Judge finds that a Guardian would be of benefit to you. The hearing will not be postponed or canceled if you do not attend. If you are unable to attend the hearing in person or you will suffer harm if you attend, the Judge can decide to hold the hearing at a place that is convenient. The Judge can also follow the rule of the Supreme Court of this State, or its local equivalent, and decide if a video conference is appropriate.

It is very important that you attend the hearing if you do not want a Guardian or if you want someone other than the person named in the Guardianship Petition to be your Guardian or if you have any other problems, you should contact an attorney or come to Court and tell the Judge.
