ELECTRONIC HOME MONITORING (EM) BY SHERIFF

(CR1829) Original (CR1830) Modification (CR1831) Reinstatement (CR1832) Termination

IT IS HEREBY ORDERED:

As a condition of pretrial release, Defendant shall be placed in the sheriff's EM program

For a period of days.

For a period of 60 days.

Until further Order of the Court.

OR

EM is terminated.

The accrued credit for time on EM is days.

IT IS FURTHER ORDERED:

- 1. The supervising authority for EM shall be the Cook County Sheriff or their designee(s).
2. Any violation of the terms and conditions of Defendant's pretrial release, including the rules and regulations of the Sheriff's EM program, may result in more restrictive conditions of pretrial release, including detention at the Cook County Department of Corrections.
3. Subject to the Movement provisions below, Defendant shall remain within their residence 24 hours a day, unless otherwise authorized by the Court or the supervising authority to leave the residence.

4. Movement:

Defendant shall, pursuant to Statute, be allowed to leave their residence/host site two days per week. Unless otherwise indicated below, that movement shall be from 8:00 AM - 4:00 PM.

As administered in the supervising authority's discretion.

The Court orders additional movement on the following days each week in conjunction with the Defendant's schedule under the Sheriff's discretion or authority.
